Instead, 5IR builds on 4IR, driven by opportunities for collaborative and cooperative synergies between humans and technologies such as artificial intelligence, where work, workers, and workplaces contribute to improving the economy, environment, and society. Consequently, the likely implication of Industry 5.0 is that it will catalyze fundamental changes in human resources management (HRM) and pressure organizations to discover emerging technologies to enhance efficiency and build an aptly skilled workforce to increase productivity.

Mathematics education is a complex system, from a system perspective, consisting of interdependent elements, including complex problems, information, medium, and environment. The application of AI, as a critical technology element, should take careful consideration of these complex factors to achieve a high-quality Mathematics education in a global perspective (Korkmaz Guler et al., 2024). Similarly, Mohammed and Watson (2019) defined AI as the skillful application of machines or technologies programmed to imitate humans. Popenici and Kerr (2017) further posited that AI is advancing rapidly in service and educational systems, supporting automated, individualized education through virtual engagement tailored to the student's convenience. Raja and Nagasubramani (2018) added that AI is highly interactive, making knowledge transfer easier and more convenient, demonstrating how reliance on this technology can simplify life.

The integration of artificial intelligence into Mathematics education, including classroom practice and teacher professional development, is of significant importance. Mathematics, often perceived as abstract and challenging, can benefit substantially from AI-powered tools that personalize learning pathways, provide immediate formative feedback, and adapt instructional tasks to individual learner needs. Proponents of the New Math movement sought to expose students to conceptual underpinnings, hoping that some would internalize the structure and thereby gain an advantage in higher-level Mathematics. Meanwhile, social efficiency progressives promoted practical, context-driven Mathematics for the majority of students, reserving abstract topics such as algebra and trigonometry for the mathematically elite. Although alternative reforms occasionally emerged outside these paradigms, they were generally limited in scope and influence, highlighting the resilience of prevailing educational assumptions while simultaneously planting the seeds for future innovation.

By the 1980s, multiple strands of thought converged to catalyze a paradigm shift in Mathematics education. Public concern regarding student performance in Mathematics, coupled with renewed interest from educators informed by research and professional development initiatives, led to a critical reassessment of teaching and learning (Leitzel, 1991; Romberg, 1989). Emphasis shifted from rote procedural learning toward understanding how students develop meaningful mathematical knowledge, incorporating cognitive theories from Piaget and Bruner (Roskopf et al., 1971) and recognizing the importance of cultural context in shaping learning experiences (Ladson-Billings, 1997). This reconceptualization culminated in the release of the National Council of Teachers of Mathematics (NCTM) Curriculum and Evaluation Standards for School Mathematics, which advocated for students' active engagement with concepts, reasoning, problem-solving, and the articulation of mathematical arguments (Carpenter & Lehrer, 1999).

Today, the Fifth Industrial Revolution (5IR) is driving a further transformation in Mathematics education. Characterized by the integration of advanced technologies such as artificial intelligence (AI), Internet of Things (IoT), cloud computing, robotics, virtual and augmented reality, and data analytics, the 5IR reshapes how societies leverage knowledge to solve complex problems (Noble et al., 2022; Dou et al., 2023). Within this context, Mathematics education is no longer limited to static curricula or traditional classroom instruction. AI-enabled adaptive

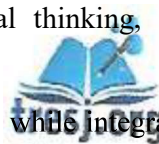
